## Chief & Council Quarterly Update – January 2026

### Amphitheatre Restoration

As we reflect on the past year, Chief and Council are proud to share the progress we've made toward our Five-Year Strategic Plan. One of our major accomplishments has been the successful completion of Phase One of the Amphitheatre Restoration Project.

Looking ahead, Phase Two will focus on completing the drystone wall surrounding the amphitheatre, adding new plantings and updated signage, and finishing the nature trail system that extends beyond the gardens. We look forward to continuing this important work together and celebrating each milestone with the community.

### Saugeen Beach

One of the most meaningful highlights of this year was the celebration marking the successful conclusion of all appeals related to our Eastern Boundary Land Claim. For generations, Saugeen people have stood strong—often in the face of immense challenges—to protect and defend this sacred area at the heart of our traditional territory. This long-awaited legal victory is a powerful affirmation of our inherent rights and a testament to the strength, perseverance, and resilience passed down by our ancestors. We proudly acknowledge and honour the former Chiefs, leaders, Elders, and community members whose dedication and unwavering advocacy made this historic court decision possible.

Through this achievement, we have rightfully regained ownership of our land. To honour this milestone, a new sign was unveiled to mark the area, symbolizing its deep cultural, historical, and spiritual importance to our people. Further work is underway to establish a permanent name and signage that will continue to reflect and uphold its significance for generations to come.

In celebration of this progress, the Beach Advisory Committee has also been actively shaping a renewed operational vision for the area. Their work ensures the beach will be stewarded in a way that respects our values, honours our responsibilities to the land, and supports our long-term vision as a Nation.

## **Employment & Training**

We have also completed the concept design phase for the upgrades and renovations to the Employment and Training Centre. Early in the new year, the final design drawings will be completed, with construction scheduled to begin in late spring.

These improvements will give the building a much-needed facelift, enhance energy efficiency, and—most importantly—create more effective and flexible spaces to deliver trade-focused training opportunities within the Saugeen community. This work supports our long-term goals of capacity building, meaningful education, and increased employment opportunities for our members.

## **Infrastructure & Housing**

We have also made progress on our 20-Year Capital Planning Study, which is now about halfway complete. The results of the community questionnaire are available on our website, and in the new year we will host a community meeting to present the interim report and gather feedback on the work completed so far.

Work has also begun on Phase Three of the multiplex project, with the lot now being cleared and funding secured to install the necessary infrastructure so the units will be ready for construction. We continue to explore additional funding opportunities to support the building of these new units.

Lastly, construction on the five Habitat for Humanity homes is well underway, with completion expected in the spring.

## **Ceremonial Building**

The Ceremonial Building at 56 Mason Drive is now approximately 90% complete. Early in the new year, the Health & Wellness Committee will finalize the building's name and cultural plan. Once construction is fully complete, we look forward to hosting a grand opening for the community to celebrate this important new space.

## **Leadership**

Over the past year, the Governance Committee has continued its focused efforts to refine the draft Governance Policy and to engage the community in meaningful dialogue. This work has included a series of information booths and focus groups designed to ensure the policy reflects the expectations of membership and supports strong, accountable leadership within our community.

A community meeting with Chief and Council will be held on Wednesday **January 28, 2026**, to conduct a final review of the policy prior to its formal adoption. We encourage all members to attend and participate in this important session. Once adopted, the Governance Policy will become a central component of the Chief and Council Orientation Package, providing essential guidance and tools to support effective leadership from the outset of each term.

Following the adoption of the Governance Policy, the Committee will shift its attention to community engagement on the Election Law. Together, these two foundational documents will significantly enhance governance practices and contribute to stronger, more transparent, and more effective leadership for the benefit of all community members.

## **Organizational Structure**

Through our Chief and Council retreat held at the end of October, we formally approved a revised organizational structure that will introduce 2 new Director positions for a total of 6 Director positions. This enhancement will strengthen service delivery, increase accountability, and provide the administrative structure necessary to support our growing organization. As our operations have expanded beyond the capacity of the original model, this updated framework will better support both staff and community members.

A key objective of the new structure is to improve communication—internally across departments and externally with the community—while reinforcing our ability to work collaboratively toward the goals and priorities outlined in our Strategic Plan.

It is our priority to continue strengthening communication between leadership and membership. To support this commitment, we will begin sharing weekly meeting highlights and providing quarterly updates to keep the community informed and engaged as our work progresses.

As we look ahead to the coming year, we extend our sincere appreciation to all staff for their hard work and dedication throughout the past year. We look forward to continued collaboration, meaningful engagement, and steady progress alongside the community.

## **Important Reminder: Snow Removal and Garbage Bin Placement**

Residents are reminded to keep driveways, roadways, and access areas clear of obstructions during the winter season to allow snowplows to operate safely and efficiently.





## Did You Know?

If you received a letter from Housing in 2025 that advised that you had arrears; you might qualify for Ontario Works to assist with bringing your rent/mortgage up to date to the maximum of \$2,500 per person/family. We can still assist with some Health & Safety repairs you need, or Ontario Works can help with a one-time payment for high Heat and/or Hydro costs.

Ontario Works maybe able to help if you are low-income person or a family on Ontario Works and ODSP clients.

Low Income Cut Off is as follows:

1 Person \$30,526.00  
2 Persons \$38,002.00  
3 Persons \$46,720.00  
4 Persons \$56,724.00  
5 Persons \$64,336.00  
6 Persons \$72,560.00  
7 Persons \$80,784.00

If your income is below these cut off amounts for your family size, please contact Ontario Works to see if you qualify for assistance with your arrears, repairs or one-time payments.

You will be required to provide a copy of your income tax assessment at the time of application and the letter from Housing.

## **Niinigiwe Hospice-Like Space**

### **Saugeen First Nation Home & Community Care**

#### **Purpose**

- To provide a wholistic culturally-safe space on Saugeen land for Saugeen Band members to be cared for in their last days to weeks of life.
- To assist family and friends with all they may need physically, emotionally and spiritually so they can support their loved one through their end-of-life journey.

#### **Criteria for admission**

- Person has a terminal illness with a life-expectancy of up to 3 months.
- Person requires care beyond what can be supported in their home due to their symptom burden, lack of family capacity, lack of necessary home amenities.
- Person has a preference to be cared for in their community rather than at the Chapman House hospice or hospital.

#### **Structure**

- Niinigiwe has all of the amenities that a full-service hospice offers: a large space for visitors, full kitchen, hospice-level washroom facilities, hospice-level bed, sleeping provisions for family, meal provision, cleaning services.
- Niinigiwe is a “hospice-like space”. This means it offers more medical services than what is available at home but less medical services than what is available in hospital or hospice. As such, if outside services are over-capacity, family involvement may be necessary to provide some of the care. This arrangement is similar to when a patient remains in their own home.
- Saugeen Home and Community Care works in partnership with Ontario Health at Home to provide hand-on-care to the Niinigiwen patient. This involves securing several hours per day of PSW care, daily nursing visits and overnight PSW care.

#### **Transfer to Niinigiwe from hospital or home requires time to:**

- Organize Saugeen nursing and PSW care.
- Send referrals to Ontario Health at Home requesting nursing, PSW, overnight PSW care. These services can take 1 to 4 days to start depending on capacity.

- Secure overnight PSW care. This is a very limited service in Grey Bruce and it is essential to providing care to a patient in a hospice-like space. If this service is not available family needs to be comfortable to provide medicines and personal care to their loved one overnight.
- Order and deliver supplies: medicine, oxygen.
- Contact the person's primary care provider or refer to a palliative care physician if one is not already involved in the person's care.
- Book transportation from home or hospital to Niinigiwe.
